As a healthcare organizational prioritizes quality and safety and to assure the health of our patients, staff, and visitors, NYULangone lealth (NYULH) has instituted the following requirements to help stop the spread of COVID19. They are applicable to all RED+contractors, service providers, vendors, and consultants (collectively "Contractors/Vendors") neal their subcontractors, sub-consultants, and personnel (collectively "personnel") had not function as extensions of staff. We have separately identified contractors that function as extensions staff.

CO vaccinated I Contractors/Vendors and their personnel who

on any premises owned or operated by NYULH or any of its affiliatesearequired to be fully vaccinated by October 25 (with their first obse by September 27). Fully vaccinated is effined as 14 days past completion to the vaccine eries. There are no exemptions addwed for any reason for any personnel working in or on any NYULH faitities.

Contractors/Vendors will be quired to maintain reords that provide proof that all personnel two provide services in an premises owned or operated by NYULH pany of its affiliates have been fully vaccinated. Upn request, Contractors/Vendors will provideouse ecords to their NYULH Project/Operations/Facilities/pother Manager of Tenant Coordinator (collectively, the "Manager").

Beginning extember 27, 2021 all Contractor/Vendopersonne must carry proof of vaccination tatus and may be askedd show proof of vaccination status at animte in or on NYULH facilities.reformay be either hard copy or electronic.

Contractors/Vendorsemain responsible for meeting project shedules ad deliverables egardless of the vaccination testus of their personnel.

Positive **©**VID19 Test Reporting

All Contractors/Vendors must immediately report any worker who testspositive for COVID 9 and has been in or on NYULH facilities it he last 48 hours. The report must include the name 10 r 21.953 0 Td [(ep)156Tw (where the worker has been while on site. The Contractor/Vendor must make the heir NYULH Manager.

dor will also provide written notice to all of their personnel as well asthoer rs whoseepsonnel were likely to have had a workplace exposure, which is defined

as having been within 6 feet of amfected person (i.e., confirmed COV19 positive) for at least 10 minutes any time during the period starting from 48 hours before symptom onset or positive diagnosis until the time the infected person was isolated.

Cleaning/Disinfecting

Contractors Vendors are responsible for following the appropriate CDC cleaning and disinfection recommendations for the immediate work area and equipment used by any individual diagnosed with COVID 19 within the previous 24 hours. If common areas such as bathrooms or shared items have
